

2. The matter was referred to the Board's disciplinary committee to assess the efforts of Mr. Foss to demonstrate the good character required by G.S. 87-42 and to apply the factors required by G.S. 93B-8.1.

3. The evidence before the committee established successful completion of the court-ordered probation as well as counseling and personality evaluation. There is no other adverse reflection on his character and no criminal activities except minor traffic violations. The panel considered that the conviction was over 10 years ago, that Respondent has a stable work and home life, that he has been employed without incident in the industry for the same employer since 2007 and he would not pose a risk to the public if licensed by the Board.

BOARD ACTION: Based upon the foregoing, the Disciplinary Committee recommended that the Board allow Respondent to take the examinations for an unlimited license contingent upon such applications being otherwise fully complete and demonstrates adequate technical and practical experience. The result was approved by the Board.

BOARD ACTION: Based upon the foregoing Findings of Fact and Conclusions of Law, it is the recommendation of the Committee that the Board enter the following order:

1. Respondent's license be reinstated subject to the terms below.

2. Upon reinstatement of the license, the license and qualification of Respondent is placed on probation for a period of one year.

3. During the period of probation the Respondent shall:

a) commit no violations of Article 4, Chapter 87 of the North Carolina General Statutes or the Rules of the Board with regard to any qualification administered by the Board; and

b) implement procedures and supervision adequate to assure that jobs typically pass both rough-in and final inspection without re-inspection;

c) implement procedures within his business adequate to assure that final inspection is requested within five (5) days of substantial completion of each installation, and that the results of the inspection request are known and of record in the business within a like period of time;

d) implement procedures to call for re-inspection, if necessary, within ten (10) days after the request for final inspection;

e) obtain no permits except for work for which Respondent or the firm in which his license is listed receives all contractual payments, for which Respondent or his firm have the contract with the property owner or general contractor, and for which all work is carried out by Respondent or his employees;

f) Respondent shall obtain permits as required prior to beginning work on any installation;

g) have written contracts signed by the licensee and customer for each installation for which licensee is responsible;

h) maintain job files or other written records of contracts made and installations performed; and

i) maintain the foregoing records, receipts and contracts for immediate review by the staff of the Board upon request.

4. In the event of violation of the terms of this Order, Respondent's license will be suspended for 6 months. The Board may further impose such additional sanctions as indicated for any new violations of G.S. 87-47.

There was no objection from Stanley O'Neal Gill and the Recommended Order was approved by the Board as a Final Decision June 15, 2017.
