## NEW OFFICE HOURS, ADDRESS AND RULES

Following are recent changes you need to know.

### OFFICE HOURS, ADDRESS

### RENEWAL OF LICENSE AFTER BEING INACTIVE 12 MONTHS OR LONGER

When renewing a license after 12 months of expiration you will need 500 hours of primary experience and the required continuing education for your license classification of which  $\frac{1}{2}$  the hours must be in the classroom. This rule was change from 1000 hours of primary experience or 16 hours of continuing education with 8 hours in the classroom. See text below.

#### 21 NCAC 18B .0406 RENEWAL AFTER EXPIRATION OF ANNUAL LICENSE

(a) Subject to Rule .0906 of this Subchapter, any licensee whose license has expired or been revoked solely because of failure to apply for renewal may apply and have the license renewed without further examination, and in compliance with the provisions contained in G.S. 87-44, if the applicant makes application within a period of 12 months immediately following the date the license expired.

(b) If the renewal application is filed more than 12 months immediately following the date the license expired, the applicant may have the license renewed if, during the 12 month period immediately preceding the date the application is filed with the Board, the applicant's listed qualified individual has obtained at least 500 hours of primary experience as defined in Rule .0202 of this Subchapter within the most recent 12 months, is current on the fee requirements set forth in Rule .0404 of this Section, pays the late fee set forth in Rule .0405 of this Section, and meets the continuing education requirements set forth in Rule .1101 of this Subchapter.

(c) An applicant failing to meet the requirements of Paragraphs (a) or (b) of this Rule may obtain a new license in accordance with Section .0200 of this Subchapter and Rule .0401 of this Section.

(d) The provisions of Section .0600 of this Subchapter apply to applicants whose last license expired on or before June 30, 1970.

### ADMINISTRATIVE FEE FOR APPLICATIONS FAILING TO QUALIFY

After staff has exhausted all efforts to receive information to allow a candidate to qualify for the exam and the candidate does not qualify, we will retain \$30.00 dollars and refund the candidate \$60.00. This is an administrative fee for processing. See text below.

#### 21 NCAC 18B .0209 FEES

(a) The application and examination fee for qualifying examinations shall be ninety dollars (\$90.00) for all classifications.

(b) The fee for review of a failed examination is twenty-five dollars (\$25.00). All reviews are supervised by the Board or staff.

(c) The examination fees for examinations in all classifications and the fees for examination reviews shall be in the form of cash, check, money order, Visa, or Mastercard made payable to the Board and shall accompany the respective applications when filed with the Board.

(d) Examination fees received with applications filed for qualifying examinations shall be retained by the Board unless:

(1) an application is not filed as prescribed in Rule .0210 of this Section, in which case the examination fee of sixty dollars (\$60.00) shall be returned and application shall be returned; or

(2) the applicant does not take the examination during the period for which application was made, files a written request for a refund setting out extenuating circumstance, and the Board finds extenuating circumstances.

## RULES (cont.)

(e) Examination review fees are non-refundable unless the applicant does not take the review, files a written request for a refund, setting out extenuating circumstance, and the Board finds extenuating circumstances.

(f) Any fee retained by the Board shall not be creditable toward any future examination fee or examination review.

(g) Extenuating circumstances for the purposes of Paragraphs (d)(2) and (e) of this Rule are the applicant's illness, bodily injury or death, or death of the applicant's spouse, child, parent, or sibling, or a breakdown of the applicant's transportation to the designated site of the examination or examination review.

## WAITING PERIOD BETWEEN EXAMINATIONS

The waiting period to retake the exam is 3 months regardless of the score on the exam. The change is that regardless of score a candidate may take the exam after 3 months. Before if the candidate made 64 and below he or she would have to wait 6 months. See text below.

### 21 NCAC 18B .0211 WAITING PERIOD BETWEEN EXAMINATIONS

(a) A person who fails a qualifying examination shall not be eligible to take another examination in the same classification until three months after the date of the failed examination.

(b) A person shall be considered a new applicant each time he or she applies to take an examination, and he or she shall file an application setting forth the information specified in G.S. 87-42 and Rules .0201 and .0202 of this Subchapter and pay the required application and examination fee. Upon completion of six month suspension and return of a license to Respondent, the license of Respondent shall be placed on probation for a period of one (1) year and during the period of probation the Respondent shall:

- (1) Commit no further violation of Article 4, Chapter 87 of the General Statutes or the rules of the Board with regard to any qualification administered by the Board;
- (2) Have written contracts or proposals for all projects having a project value in excess of one hundred dollars (\$100.00) signed by the licensee and customer for each installation for which the licensee is responsible;
- (3) Licensee shall not allow a permit to be obtained or his license number to appear upon a permit except for work which he or his employees perform, over which he will provide general supervision until the completion of the work, for which he holds an executed contract with the licensed general contractor or property owner and for which he receives all contractual payments;
- (4) Maintain job files or other written records of contracts made and installations performed;
- (5) Utilize only employees receiving a W-2 from the Respondent firm and only on projects for what the firm has its electrical contracts and provide supervision by a qualified person; and
- (6) Maintain records detailing and documenting compliance with the provisions of the probation order which records shall be available for inspection at any time during normal business hours upon request of the staff of the Board.

In the event of failure to comply with the terms of probation, Respondent shall appear before the Disciplinary Committee to show cause why his license and qualifications should not be either suspended or revoked. The Board may impose such additional sanctions as indicated by any new violation of G.S. 87-47.

  - a) commit no violations of Article 4, Chapter 87 of the North Carolina General Statutes or the Rules of the Board with regard to any qualification administered by the Board; and
  - b) complete the Business Class offered by the Board.

In the event Respondent fails to comply with the terms of his probation then Respondent shall appear before the Disciplinary Committee to show cause why his license and qualifications should not be either suspended or revoked.

There was no objection from Mr. Johnson and the Recommended Order was approved by the Board as a Final Decision December 3, 2015.

Upon review of the complaint and the results of staff investigation, and pursuant to the standards set forth in G. S. 87-47 (a2) and (a3), the Board, acting through its staff, proposed a reprimand, pay a civil penalty of \$250.00 and a probationary period of two (2) years subject to the following conditions:

(1) Pay restitution in the amount of \$3500.00 to Stephanie Ross within 45 days of this Notice of Violation;

(2) George Andrew Moore must complete the Contractor Business Class (Umpire Technologies Group, Inc., (919-624-3456) approved by the NC State Board of Examiners of Electrical Contractors and present evidence to the Board of a passing grade by December 9, 2016;

(3) Have written contracts or proposals for all projects having a project value in excess of one hundred dollars (\$100.00) signed by the licensee and customer for each installation for which the licensee is responsible;

(4) Maintain job files or other written records of contracts made and installations performed;

(5) Utilize only employees receiving a W-2 from the Respondent firm and only on projects for what the firm has its electrical contracts and provide supervision by a qualified person;

(6) Licensee shall not allow a permit to be obtained or his license number to appear upon a permit except for work which he or his employees perform, over which he will provide general supervision until the completion of the work, for which he holds an executed contract with the licensed general contractor or property owner and for which he receives all contractual payments;

(7) Maintain records detailing and documenting compliance with the provisions of the probation order which records shall be available for inspection at any time during normal business hours upon request of the staff of the Board; and

(8) Commit no further violation of Article 4, Chapter 87 of the General Statutes or the rules of the Board.

Notice of Violation noted, in the event of failure to comply with the terms of probation, electrical contracting license and George Andrew Moore's right to serve as a qualified individual on any license will be suspended for a period of one (1) year. Prior to reinstatement, restitution to Stephanie Ross must be paid and Contractors Business Class must be completed. The Board may impose any such additional sanctions as are appropriate in the discretion of the Board for any further violations of Article 4, Chapter 87 of the General Statutes or the Rules of this Board.

On December 9, 2015 George Andrew Moore agreed to the terms of this Notice of Violation.

## RECENT DISCIPLINARY ACTION TAKEN BY THE BOARD

George Andrew Moore failed to comply with terms of Notice of Violation. Staff received no evidence of civil penalty payment and restitution has not been paid to Stephanie Ross as required by probation of Notice of Violation.

Based on the requirements of the Notice of Violation and the foregoing facts, the Board's Staff concluded that license and qualifying status must be suspended. Suspension letter February 1, 2016 was sent advising license and qualifications would be suspended. This action was an agency decision which give you a right to an administrative hearing before the Board. To exercise such right, you must file a request or petition with the Board within 30 days, pursuant to Article 3A, Chapter 150B of the General Statutes. George Moore did appeal Staff's decision on February 26, 2016.

**BOARD ACTION:** Based on the foregoing Findings of Fact, the Committee makes the following recommendations:

(C) Utilize only employees receiving a W-2 from the Respondent firm and only on projects for what the firm has its electrical contracts and provide supervision by a qualified person;

(D) Licensee shall not allow a permit to be obtained or his license number to appear upon a permit except for work which he or his employees perform, over which he will provide general supervision until the completion of the work, for which he holds an executed contract with the licensed general contractor or property owner and for which he receives all contractual payments;

(E) Maintain records detailing and documenting compliance with the provisions of the probation order which records shall be available for inspection at any time during normal business hours upon request of the staff of the Board; and

(F) Commit no further violation of Article 4, Chapter 87 of the General Statutes or the rules of the Board.

2. In the event of failure to comply with the terms of probation, your license and the right to serve as a listed qualified individual on any license will be revoked. The Board may impose such additional sanctions as indicated by any new violation of G.S. 87-47.

There was no objection from Mr. Moore and the Recommended Order was approved by the Board as a Final Decision June 8, 2016.

6. Respondent failed to comply with the terms of his probation which, inter alia, required that Respondent maintain job files and have written contracts or proposals signed by the licensee and customer for each installation.

7. The Respondent has demonstrated a pattern of failing to comply with the Board's laws and rules.

8. Respondent's actions amount to unethical conduct in the practice of electrical contracting.

9. The Panel takes note of the fact that Respondent has acknowledged the need for better communication and also the need for full compliance with the terms of his probation and the laws and rules of the Board. f. Commit no further violation of Article 4 of the General Statutes or the rules of the Board with regard to any qualification administered by the Board.

Persons with criminal convictions are evaluated to determine if the matter is under the purview of the Board and may be resolved by consent agreement signed by the individual stating that they will be in full compliance of the court imposed sanctions and sanctions of the Board. The individual further acknowledges that failure to comply with the court or Board sanctions could lead to formal proceedings by the Board and more serious sanctions against the individual.

## RECENT DISCIPLINARY ACTION TAKEN BY THE BOARD

### NON-LICENSEE - WARNINGS AND WARNING AFFIDAVITS

Staff may obtain by consent a warning affidavit in connection with the first offense of unlicensed individuals offering to engage in electrical contracting as defined in Article 4, Chapter 87 of the General Statutes of North Carolina. The Board may apply to the courts to restrain and enjoin such violations as unlicensed individuals engaging in electrical contracting. The North Carolina Electrical Contracting Licensing Laws, specifically General Statutes 87-43, 87-43.1 and 87-48 has been explained to each individual listed below. Staff obtained by consent a sworn warning affidavit signed by the unlicensed individual and verbal assurance from the unlicensed individual stating that they will refrain from engaging or offering to engage in any electrical contracting in the State of North Carolina until such time they have qualified and obtained an electrical contracting license from the Board.
