MESSAGE FROM THE CHAIRMAN

Greetings from the Chairman of the NC State Board of Examiners of Electrical Contractors. Fiscal Year July 1, 2017 - June 20, 2018 was a busy one for the Board. We started with 12,626 licensees on July 1, 2017 and ended with 12,746 licensees on June 30, 2018. The first time in years there were more licensees at the end of the year than the beginning. Now a deeper look at the dash (-) between July 1, 2017 – June 30, 2018.

The dash is a small symbol, but when put between two dates it represents all that transpired between the dates. The dash between birthdate and death date, on a tombstone, represents one's entire life. How we live each day is represented by that dash.

Looking at the beginning of the "dash" Epsie Stevens became Office Manager after the retirement of Mary Higgins. Epsie has worked for the Board for 23 years and was previously the office manager before taking leave to take care of her mother. She grabbed the ball on day one and took off running.

October brought many changes in that William "Gus" Lawson retired on October 31, 2017. Also, in October, the Board changed the rules on experience back to what they were in 1999. Back to what the requirements were when most of us obtained a license. We also changed the passing score to 70 to mirror the states that border us, as well as across the nation. This was done because of the decline in the youth pursuing work in the trades and the growing needs for personnel of our contractors. There were also comparisons being made by our legislature on the requirements of other states as

well. The Board and staff continue to go to career days at high schools and middle schools and promote our industry to the students. Has this made a difference? I would answer yes. At the beginning of the fiscal year we had 94 licensees that were 30 years and younger out of the 12,746. We now have 109 licensees 30 years old and younger. That is not moving the needle much, but it is moving it in the right direction.

January brought in our new Field Investigator, Hal Little. Hal came to us from the city of High Point. Hal has several years' experience as an electrical inspector as well as being an electrical contractor. Hal has jumped in and took off like he had been here for a while. Be sure to thank Hal when you see him.

We launched our "Laws and Rules" classes across the state which are being done free of charge and you receive 4 hours of classroom continuing education. The classes are very beneficial for all contractors, inspectors, and permit technicians. The registration for these classes is first come first serve so check the board's website early to get a seat. This is being held in different regions and has been very successful. We have decided to continue these classes so please look at our website for information and registration sheet.

The Board has looked at several of our reciprocity agreements to determine if our, NC, contractors are being treated fairly. We discovered that a South Carolina equivalent to our Limited license could get a license here in North Carolina through reciprocity, but North Carolina Limited Licensee could not

reciprocate to South Carolina. The Board renegotiated that agreement and I am happy to report that our Limited Licensee can now go to South Carolina and receive up to a group 2, commercial electrical contractors license through reciprocity.

The Board has been trying for years to reach a reciprocity agreement with Tennessee but had no success. We reached out again and with a lot of hard work, inked a reciprocity agreement with Tennessee, in which our Unlimited Licensee can obtain a Tennessee Master's License. The only requirement is to take a short business exam. The same applies to a Tennessee Master License obtaining an Unlimited License in North Carolina through reciprocity. This brings us to 11 states we have reciprocity with and we will be looking at others in the future.

So you see, the dash may be a small symbol but it represents a whole lot of activity. I wish you continued success in our industry.

2017 CONTINUING EDUCATION INSTRUCTOR OF THE YEAR

The Board presented to Mr. Harold Richard Boyd the 15th Annual Continuing Education Instructor of the Year award.

Through the years Mr. Boyd has been a consistent resource for our industry, serving as an educator and mentor to many electricians and contractors. Mr. Boyd is a continuing education electrical instructor and owner of Boyd Electrical Seminars. After the Electrical Board started to require continuing education to renew electrical contractor's license, Mr. Boyd started teaching approved continuing education classes soon after. Mr. Boyd's exam prep and continuing education courses are an asset to those in the industry and those who seek quality education services.

Mr. Boyd was born August 31, 1947 in Washington, NC. Mr. Boyd lived in Bath, NC on their family farm until he was 4 years old.

The family then moved to Newport News, VA as his dad worked at the Newport News Ship Yard for 40 years. At the age of 12 the family moved to Smithfield and remained there until graduation from Smithfield High School in 1966.

Mr. Boyd then joined the US Army fresh out of high school. After basic training, Mr. Boyd then spent a year in Vietnam from 1967 to 1968, he was released on August 20, 1968.

After returning home Mr. Boyd moved back to Newport News and joined the Police Department. However, this career was short lived as Police work just didn't suit Richard.

Later that year in 1968 Mr. Boyd moved to Statesville and worked in a box manufacturing company, that too was short lived as Mr. Boyd is an out of the box kind of guy.

It was then that Mr. Boyd found his spark in life. He started working for Modern Electrical Company and stayed there for 3 years at just \$3 an hour. Mr. Boyd got the money bug and was offered a different job wiring the famed Signal Hill Mall for \$3.25 an hour. He was rolling in the cash and following the electrical job circuit. Mr. Boyd's last private industry job was with Electric of Atlanta. He was the electrical superintendent for all of the Nursing Homes throughout the Piedmont Area.

The opportunity of light was then given to Mr. Boyd through an Inspector position with the City of Statesville. Although the position was temporary to start with in 1974, it became full time in 1975. Richard was only the second electrical inspector ever hired for Statesville.

In 1992 Iredell County took over the inspections for the City and Mr. Boyd was then a full time electrical inspector for the County. On Friday he worked for the City and on Monday when the lights cut on he was and Iredell County employee.

In all these years he has attended many college courses including UNC Chapel Hill, NC State, Mitchell and Catawba Valley Tech.

Mr. Boyd passed the unlimited contractors exam September 17, 1977. He still holds his Level III Electrical Inspector Certificate as well as a Level I Certificates in Building, Plumbing & Mechanical trades.

In 2004 he was promoted to the Code Enforcement Field Supervisor position with the County. He was then taken out of the field for daily inspections and was the supervisor of the Departments inspectors.

In 2008 he became the Assistant Director of Code Enforcement. Mr. Boyd remained the Assistant Director until 2015 when he retired. He still remains very active with the Department in a consultant/part-time basis.

Mr. Boyd's love of fishing carries him to VA coastal waters on a regular basis. He purchased a boat and named it after his Mom, "Annie E".

When his two boys were younger, he coached they basketball, volleyball, baseball and soccer teams. He also worked part-time as the girls high school volleyball coach for 3 years a Southview Christian School. He was their assistant coach for the boys baseball, basketball and soccer teams. He loves working with kids and now has three grandchildren. Levi who is now 7 and lives in Lake Tahoe with his dad Jason. The smallest grandbabies are just 4 month old twins, one boy & one girl. They live in Charlotte with their dad Neal.

Mr. Boyd is a Member of the Western Avenue Baptist Church.

Mr. Boyd's mentors when he started in the inspection field were Dick Boyd, Dave Maddrey and Curtis Kennedy.

The Board would like to express their appreciation and gratitude to Mr. Boyd's continued dedication and service of being an instructor for the Board's Continuing Education Program.

The Order further found RCI Electrical Contracting Corp. "knowingly misrepresented its payment for equipment and supplies" and thereby engaged in "fraudulent conduct." As part of the Order, A.R. Chesson Construction Company, Inc. was found to have been damaged by the breach and repudiation of RCI Electrical Contracting Corp. and awarded a judgment in the amount of \$1,656,495.00.

5. Thereafter, A.R. Chesson Construction Company, Inc. and Andy Holliman filed a complaint with this Board against the Respondent Harjap Singh.

6. A Notice of Board Proceeding was issued on April 13, 2017 which gave notice that the investigation of staff, and the findings in the Order, appeared to establish Respondent and RCI Electrical Contracting Corp.:

- a. contracted to wire the electrical project at the Hertford County Courthouse and Governmental Center in Winton, NC and abandoned the project;
- b. failed to adequately supervise the project as evidenced by Hertford County Inspection Records;
- c. fraudulently submitted reimbursement requests for equipment and supplies totaling \$83,400.00;
- d. failed to make payment of the Martin County judgment in case number 15 CVS 319;
- e. failed to notify the Board's office about changes in location, mailing address, and contact information; and
- f. engaged in unethical conduct, fraud and deceit in the practice of electrical contracting.

7. Respondent raised concerns before the Disciplinary Committee including that: the firm A.R. Chesson

Construction Company, Inc. was at fault and played a role, along with the owner's representatives, in preventing RCI Electrical Corp. from timely performing the contract; that the resulting civil suit was not contested, and the Order contained findings only as proffered by the Plaintiff, that the Judgment was not against Respondent individually, and that the electrical work was up to standards and properly supervised.

8. The Committee finds that Respondent and RCI Electrical Contracting Corp.:

- a. contracted to wire the electrical project at the Hertford County Courthouse and Governmental Center in Winton, NC and abandoned the project; and
- b. failed to adequately supervise the project as the term "supervision" is defined by 21 NCAC 18B.0907; and
- c. undertook a project that was not properly planned or supervised and thereby engaged in malpractice as that term is defined by 21 NCAC 18B.0908;

BOARD ACTION: Based upon the foregoing Findings of Fact and Conclusions of Law, it is the recommendation of the Committee that the Board enter the following order:

1. The Respondent is placed on probation for a period of twelve months.
2. During the period of probation, the Respondent shall:
 - a) Enroll and complete the Special Business Course as approved by the Board within six months of this Order or the first available course date;
 - b) commit no violations of Article 4, Chapter 87 of the North Carolina General Statutes or the Rules of the Board with regard to any qualification administered by the Board;
 - c) implement procedures and supervision adequate to assure that jobs typically pass both rough-in and final inspection without re-inspection;
 - d) implement procedures within his business adequate to assure that final inspection is requested within five (5) days of substantial completion of each installation, and that the results of the inspection request are known and of record in the business within a like period of time;
 - e) implement procedures to call for reinspection, if necessary, within ten (10) days after the request for final inspection;
 - f) obtain no permits except for work for which Respondent or the firm in which his license is listed receives all contractual payments, for which Respondent or his firm have the contract with the property owner or general contractor, and for which all work is carried out by Respondent or his employees;
 - g) obtain permits as required prior to beginning work on any installation;
 - h) have written contracts signed by the licensee and customer for each installation for which licensee is responsible;
 - i) maintain job files or other written records of contracts made and installations performed; and

j) maintain the foregoing records, receipts and contracts for immediate review by the staff of the Board upon request.

3. In the event of a violation of the terms of this Order, Respondent's license will be suspended. The Board may also impose such additional sanctions as indicated by any new violations of G.S. 87-47.

4. That in the event of a violation of the terms of this probation order, this Order may be entered into evidence together with evidence of any such violation and the Board may take such action including revocation or

suspension of license as is justified by the new evidence in addition to the suspension set out above.

5. During the period of probation, the foregoing records and the contracting activities of the Respondent shall be monitored by the staff of the Board.

6. This Order becomes effective thirty days from this date. There was no objection from Harjap Singh and Consent Order was approved by the Board as a Final Decision December 7, 2017.

CONSENT AGREEMENTS

Criminal background checks a randomly conducted on examination applicants at the time examination applications are received and on listed qualified individuals at the time of issuance of a license and license renewal. Persons with criminal convictions are evaluated to determine if the matter is under the purview of the Board and may be resolved by consent agreement signed by the individual stating that they will be in full compliance of the court imposed sanctions and sanctions of the Board. The individual further acknowledges that failure to comply with the court or Board sanctions could lead to formal proceedings by the Board and more serious sanctions against the individual.
