

A MESSAGE FROM FORMER BOARD CHAIRMAN GERALD HARVELL


It is finally here, time for me to leave, but is not farewell. What an honor it has been to have served all of you for the past seven years; I cannot believe it is over already.



NEW EXAMINATIONS RULE

IMPORTANT NEW EXAMINATIONS RULE: BRING YOUR OWN BOOKS

EFFECTIVE 02-01-2021

The Board has voted to allow candidates to bring their own reference materials for use during examinations. The examinations are OPEN BOOK. The references listed below are the ONLY references allowed in the examination center. References shall be softbound, spiral, or hardbound. Loose leaf references are not allowed. Candidates are responsible for bringing their own references to the examination center.

Reference materials may be highlighted, underlined, and/or annotated prior to the examination session. Notes on the pages of the reference materials are allowed. However, **if notes are written in pencil, they MUST be highlighted**; if written in pen, they DO NOT need to be highlighted. NO partial references will be allowed as acceptable reference materials for exams.

References may not be written in during the examination session. Any candidate caught writing in the references during the examination will have the references confiscated and will be reported to the Board. Furthermore, candidates are not permitted to bring in any additional papers (loose or attached) within their approved references. Any additional materials will be removed from the references and confiscated.

References may be tabbed with permanent tabs only. Temporary tabs, such as post-It notes or stapled tabs, are not allowed and must be removed from the reference before the exam will begin. Likewise, divider tabs are not allowed.

Writing in the references, bringing unpermitted additional papers into the test center, or presence of improper tabs, shall be considered evidence of cheating and grounds for invalidation of the exam, disqualification for future exams, and discipline.

<u>The following list of tabs may be used:</u> (These items may be purchased at local office supply stores.)

Acceptable Tabs: Redi-Tag Self-Stick Permanent Adhesive Index Tabs

Unacceptable Tabs: Post-It Index Flags, Post-It Flags, Self-made tabbing, or reinforcement of any kind.

Reference Materials to bring to testing center:

- 1. The National Electrical Code, 2017 edition.
- 2. National Fire Alarm Code, 2013 edition (Limited, Intermediate, Unlimited, SP -SFD and SP -FA/LV).

NEW RECIPROCITY WITH SOUTH CAROLINA

NEW RECIPROCAL AGREEMENT BETWEEN NC AND THE SC RESIDENTIAL BUILDERS COMMISSION

The Board has recently entered into an additional reciprocal agreement with the South Carolina Residential Builders Commission.

Previously, only the NC Limited, Intermediate and Unlimited license classifications were transferrable to SC. Likewise, only SC commercial electrical licensees holding an EL-2 through EL-5 could transfer their license to NC.

Thanks to this new reciprocal agreement, NCBEEC licensee's and qualified individuals who hold a Special-Restricted Single-Family Dwelling (SP-SFD) license can now reciprocate with the state of South Carolina!

...WHAT DOES RECIPROCITY MEAN?

"An agreement or relationship between states, or localities who exchange things between one another for mutual benefit."

In terms of electrical licensing:

- Reciprocity means a licensee and/or qualified individual can transfer their qualifications and exam from one state to another, or vice versa.
- <u>The exam is waived in the reciprocating state</u> (the state you're transferring to) since you've already taken and passed a similar exam in your home state.

WARNINGS: NON-LICENSEE

WARNINGS AND WARNING AFFIDAVITS ISSUED TO FIRST OFFENSE UNLICENSED INVIDIDUALS


Staff may obtain by consent a warning affidavit in connection with the first offense of unlicensed individuals offering to engage in electrical contracting as defined in Article 4, Chapter 87 of the General Statutes of North Carolina. The Board may apply to the courts to restrain and enjoin such violations as unlicensed individuals engaging in electrical contracting. The North Carolina Electrical Contracting Licensing Laws, specifically General Statutes 87-43, 87-43.1 and 87-48, have been explained to all individuals listed.

Staff obtained by consent a sworn warning affidavit signed by the unlicensed individual and verbal assurance from the unlicensed individual stating that they will refrain from engaging or offering to engage in any electrical contracting in the State of North Carolina until such time they have qualified and obtained an electrical contracting license from the Board.

Non-licensees who were issued warnings and/or warning affidavits are listed in the adjacent table.



VIOLATION(S):

- 1. On August 4, 1989, Respondent Rite Lite Signs, Inc. was issued a Special Electric Restricted Sign License with number SP.ES 14932 and with Respondent David Ralph Catchpole, Jr. as the listed qualifier.
- 2. Respondents manufacture and install electric signs throughout North Carolina as well as in surrounding states.
- 3. During 2020, Respondent firm had approximately nine full-time employees.
- 4. Respondent Catchpole worked on a part-time, as needed basis. Respondent Catchpole does not visit most installation projects but instead relies upon other personnel to supervise electrical installations.
- 5. With regards to Respondents' project, involving the installation of electric signs for an Amazon Distribution Warehouse ("Amazon Project"), located at 1610 Old Greensboro Road, Kernersville, NC Respondents allowed a former employee to supervise that installation.
- 6. Respondents failed to obtain an electrical permit from the local authority having jurisdiction over building code permitting and enforcement for the Amazon project and failed to respond to repeated requests and reminders from the local authority having jurisdiction (Town of Kernersville) and the Board's investigator regarding the need to obtain a permit and to correct code issues for the Amazon Project.
- 7. Respondent Catchpole failed to properly supervise multiple electrical projects in North Carolina, including the Amazon Project.
- 8. Respondent Catchpole was not readily on active duty and available to supervise the electrical installations for Respondent firm while the electrical installations were in process.
- 9. A review of open and expired permits for Respondents in Cabarrus County revealed numerous open and expired permits.
- 10. Respondents' conduct demonstrates incompetence, misconduct, and a failure to supervise.

- 1. That the Board impose a civil penalty of \$1000.00 upon the Respondents to be paid prior to the reinstatement of license after the suspension period outlined below.
- 2. That the license of Respondent firm and the status of Respondent David Ralph Catchpole, Jr. as a qualifying individual are SUSPENDED for a period of three (3) months.
- 3. The license of Respondents may be reinstated without further action by the Board at such time, after this Order has been in effect for a period of three (3) months.
- 4. That upon completion of the period of suspension the Respondents' license to engage in business as an electrical contractor be placed on probation for a period of twenty-four (24) months, effective upon final action by the Board.

- 5. During the period of probation, Respondent shall comply with the following conditions of probation:
- (a) have written contracts or proposals signed by the licensee and customer for each installation for which licensee is responsible;
- (b) obtain permits as required for each contract prior to commencement of work, retain a copy of the permit in the job file for each particular installation and assure that a final inspection has been performed by the Local Code Enforcement Official for each installation;
- (c) maintain job files or other written records of contracts made and installations performed;
- (d) submit quarterly reports documenting his compliance with the provisions of this probation order by either sending them directly to the Board's office or contacting the Board's Field Representative that the documents are ready for his review; and,

Respondents failed to obtain a required electrical permit for this project. Respondents accepted consideration for the project and abandoned it without performing any work or returning the
- consideration. Respondents failed to complete the project forcing the owners to hire other contractors to complete the project.
- 4. Respondents contracted a commercial project known as the Tory County Shop and located at 9049 Industrial Blvd., Leland, NC in excess of the scope of their license. Respondents failed to obtain a required electrical permit for
- this project. Respondents failed to complete the project forcing the owners to hire other contractors to complete the project.
- 5. Respondents contracted an electrical project for a residence located at 817 Sweetbriar Road, Southport, NC. Respondents failed to obtain a required electrical permit for this project. Respondents failed to complete the project forcing the owners to hire other contractors to complete the project. Respondents' failure to complete the project caused damage to the structure.
- 6. Respondents allowed a non bona fide employee,

Timothy Pyles, to perform work requiring an electrical license under Respondents' license at the project located at 817 Sweetbriar Road, Southport, NC.

- 7. Respondents undertook projects that were not supervised and not performed in a manner that could be reasonably expected to be completed in accordance with codes, specifications and industry standards.
- 8. Respondents engaged malpractice or unethical conduct in the use of a license.

BOARD ACTION:

- 1. This Board was created Pursuant to the provisions of Article 4, Chapter 87, of the General Statutes of North Carolina and has the authority to discipline conduct and sanction licensees Pursuant to N.C.G.S. §87-47.
- 2. N.C.G.S. §87-47 provides that the Board may revoke or suspend the qualification of a qualified individual or refuse to issue a license, for, inter alia, misconduct or misrepresentation in the practice of or in carrying on the business of electrical contracting.
- 3. Respondents' actions violated N.C.G.S. § 87-47, and the Rules of the Board, including Rules: 21 NCAC 18B.0907, 21 NCAC 186.0908, and 21 NCAC 188.0909.
- 4. Respondent actions as set forth above were malpractice in the use of a license.

Based upon the foregoing Findings of Fact and Conclusions of Law, it is the recommendation of the Committee that the Board enter the following order as to the licensee and the firm:

- 1. Respondents' qualifications and license shall be suspended for a period of 12 months.
- 2. After the period of suspension, Respondent's license shall be placed on probation for a period of 48 months.
- 3. During the period of probation, the Respondents shall:
- a) Commit no violations of Article 4, Chapter 87 of the North Carolina General Statutes or the Rules of the Board with regard to any qualification administered by the Board;
- b) Implement procedures and supervision adequate to assure that jobs typically pass both rough-in and final inspection without reinspection;

- c) Implement procedures within his business adequate to assure that final inspection is requested within five (5) days of substantial completion of each installation, and that the results of the inspection request are known and of record in the business within a like period of time;
- d) Implement procedures to call for reinspection, if necessary, within ten (10) days after the request for final inspection;
- e) Obtain no permits except for work for which Respondent or the firm in which his license is listed receives all contractual payments, for which Respondent or his firm have the contract with the property owner or general contractor, and for which all work is carried out by Respondent or his employees;
- f) Obtain permits as required prior to beginning work on any installation;
- g) Have written contracts signed by the licensee and customer for each installation for which licensee is responsible;
- h) Maintain job files or other written records of contracts made and installations performed;
- i) Maintain the foregoing records, receipts and contracts for immediate review by the staff of the Board upon request; and
- j) Engage in business only in the name in which their electrical license is issued with regards to work for which a license is required;
- k) Attend and pass a Contractor Disciplinary Course offered by Umpire Technologies or other third-party provider approved by Board staff before reinstatement of license;
- I) Attend and pass the free Laws and Rules Class offered by Board staff before reinstatement of license;
- m) Attend and pass a standard level I Electrical Inspector Course approved by the North Carolina Code Officials Qualification Board before reinstatement of license;
- n) Demonstrate to the satisfaction of Board staff that Respondents have reimbursed owners of Paw's Place Dog Rescue and located at 242 George II Hwy., Winnabow, NC, all funds received for the performance of electrical contracting before reinstatement of license by production of a written statement by the Owners or similar evidence; and
- o) Demonstrate to the satisfaction of Board staff that Respondents have reimbursed owners of Tory County Shop and located at 9049 Industrial Blvd., Leland, NC all funds received for the performance of electrical contracting before reinstatement of license by production of a written statement by the Owners or similar evidence.
- 3. In the event Respondents fail to comply with the terms of this probation, then Respondents' license shall be REVOKED.

- 4. The June 26, 2019 Notice of Violation reprimanded Respondents, assessed a \$500.00 civil penalty against Respondents and placed Respondents on probation with certain conditions for a period of 1year .
- 5. Among the conditions of the probation were that Respondents were to: attend and pass the Laws and Rules and pass the Disciplinary Business Class by September 26, 2019.
- 6. The June 26, 2019 Notice of Violation stated that a failure to comply with the terms of the agreed to probation set forth in that Notice would result in a 12 month suspension of the Respondents' license and the right of the individual Respondent to serve as a qualified individual I for any firm for a 12 month period.
- 7. On July 1, 2019 Respondents agreed to the terms and conditions set forth in the June 26, 2019 Notice of Violation.
- 8. The June 26, 2019 Notice of Violation was approved by the Board as a Final Decision on September 12, 2019.
- 9. Thereafter, Respondents failed to comply with the terms of probation in that Respondents: failed to timely attend and pass the Disciplinary Business Class by September 26, 2019 (though the class was completed by Respondent on December 10, 2020).
- 10. Respondent also failed to comply with the terms of his probation in that he failed to maintain written contracts for projects with a project value in excess of \$100.00.
- 11 . Respondent did meet with the Board's investigator on October 28, 2020 but failed to produce requested documentation to show compliance with the terms of his probation.
- 12. Respondent in a written and sworn statement dated October 28, 2020 admitted:
- a. He employed Danny Smart in 2019 but failed to employ him as a W-2 employee;
- b. Respondents completed approximately 100 projects since July 1, 20 19 but did so without contracts signed by the customer and

Respondent Redmon; and

- c. Respondent Redmon has been unable to work since January of 2020 due to health issues but has allowed electrical work to continue by Danny Smart and Andrew Parker without supervising that work.
- 13. Respondent Redmon has:
- a. violated the terms of his probation;
- b. aided and abetted unlicensed activity;
- c. failed to supervise work taking place under his license in violation of 21 NCAC 18B .0907;
- d. allowed permits to be obtained for work over which he provided no supervision and which was performed by non bona fide employees; and
- e. engaged in misconduct in violation of N.C.G.S. §87-47.

BOARD ACTION:

- 1. This Board was created Pursuant to the provisions of Article 4, Chapter 87, of the General Statutes of North Carolina and has the authority to discipline conduct and sanction licensees Pursuant to N.C.G.S. §87-47 2. N.C.G.S. §87-47 provides that the Board may revoke or suspend the qualification of a qualified individual or refuse to issue a license, for, inter alia, misconduct or misrepresentation in the practice of or in carrying on the business of electrical contracting.
- 3. Respondents' actions violated N.C.G.S. § 87-47 and the terms of his probation.

Based upon the foregoing Findings of Fact and Conclusions of Law, it is the recommendation of the Committee that the Board enter the following order as to the licensee and the firm.

- 1. Respondents' license shall be REVOKED.
- 2. Respondent firm may request reinstatement of the license by personal appearances of both a Qualified Individual other than Respondent

Redmon and their Chief Executive Officer before this Disciplinary Committee of the Board.

- 3. After the passage of 5 years, from the **EFFECTIVE DATE** of the Board's Final Order in this matter, Respondent Eric Redmon may request reinstatement of his right to serve as a listed qualified individual in a personal appearance before the Disciplinary Committee of the Board but only after retaking and passing a Board licensure examination and meeting all other requirements for reinstatement.
- 4. Should the Respondents' qualifications and license be reinstated, Respondents shall be placed on probation for a period of 60 months.
- 5. During any such period of probation, the Respondents shall:
- a) Commit no violations of Article 4, Chapter 87 of the North Carolina General Statutes or the Rules of the Board with regard to any qualification administered by the Board;

- 3. On September 19, 2013, Respondents were reprimanded by the Board and placed on probation.
- 4. On February 11, 2014, the Board approved a Notice of Violation Respondents entered into with Board staff that included a sanction of a civil penalty and probation. The Respondent agreed to those terms.
- 5. On December 12, 2019, the Board approved another Notice of Violation Respondents entered into with Board staff that included a sanction of a civil penalty and probation. The Respondent agreed to those terms.
- 6. The December 12, 2019 Notice of Violation included as a condition of the probation that Respondents complete a Contractor Business Disciplinary Class and present evidence of passing that class by April 1, 2020.
- 7. Respondents failed to complete the Contractor Business Disciplinary Class and present evidence of passing that class by April 1, 2020, thereby violating the terms of their probation.
- 8. Pursuant to the terms of the December 12, 2019 Notice of Violation, the license and qualifications of Respondents are to be suspended for a period of twelve (12) months for any violation of probation.
- 9. Respondents have since completed the required Business Disciplinary Class and the delay in compliance was due in part to procrastination by Respondents and due in part to a class cancellation resulting from the pandemic.

BOARD ACTION:

- 1. That the license of Respondent firm and the status of Respondent Alphonso Russell, Sr. as a qualifying individual be placed on an extended period of probation for a period of twelve (12) months, effective upon final action by the Board.
- 2. During the period of probation, Respondents shall comply with the following conditions of probation:
- (a) have written contracts or proposals signed by the licensee and customer for each installation for which licensee is responsible;
- (b) obtain permits as required for each contract prior to commencement of work, retain a copy of the permit in the job file for each particular installation and assure that a final inspection has been performed by the Local Code Enforcement Official for each installation;
- (c) maintain job files or other written records of contracts made and installations performed;
- (d) submit quarterly reports documenting his compliance with the provisions of this probation order by either sending them directly to the Board's office or contacting the Board's Field Representative that the documents are ready for his review; and,
- (e) maintain records detailing and documenting his compliance with the provisions of this probation order which records shall be available for inspection at any time during normal business hours upon request of the staff of the Board; and
- (f) commit no violation of Article 4, Chapter 87 of the General Statutes or the Rules promulgated by the Board.

There was no objection from ALPHONSO RUSSELL, SR the Recommended Order was approved by the Board as a Final Decision June 17, 2021.

- 1. On August 4, 2001, the Board issued an unlimited license U 24447 to Everyday Electric with Richard Larry Wrenn, Jr. as the listed qualified individual.
- 2. On February 2, 2020, the Board approved a Notice of Violation Respondents entered into with Board staff that included a sanction of a civil penalty and a twelve (12) month probation with various terms and conditions set forth therein. The Respondent had previously agreed to those terms on October 6, 2019.
- 3. The February 2, 2020 Notice of Violation included, as a condition of the probation that Respondents attend and pass a Standard Level I Electrical Inspector Course approved by the NC Code Officials Qualifications Board by April 30, 2020.
- 4. Respondents failed to complete a Standard Level 1 Electrical Inspector Course and present evidence of completing that class to Board staff by April 30, 2020, thereby violating the terms of their probation.
- 5. Pursuant to the terms of the February 2, 2020 Notice of Violation, the license and qualifications of Respondents are to be suspended for a period of twelve (12) months for any violation of probation.
- 6. Respondents have since completed the required Standard Level I Electrical Inspector Course Class and the delay in compliance was due in part to Respondent Wrenn's health condition and due in part to a class cancellation resulting from the pandemic.
- 7. The panel finds good cause to deviate from the sanction set forth in the February 2, 2020 Notice of Violation

BOARD ACTION:

- 1. That the license of Respondent firm and the status of Respondent Richard Larry Wrenn, Jr. as a qualifying individual be placed on an extended period of probation for a period of six (6) months, effective upon final action by the Board.
- 2. During the period of probation, Respondents shall comply with the following conditions of probation:
- (a) have written contracts or proposals signed by the licensee and customer for each installation for which licensee is responsible;
- (b) obtain permits as required for each contract prior to commencement of work, retain a copy of the permit in the job file for each particular installation and assure that a final inspection has been performed by the Local Code Enforcement Official for each installation;
- (c) maintain job files or other written records of contracts made and installations performed;
- (d) submit quarterly reports documenting his compliance with the provisions of this probation order by either sending them directly to the Board's office or contacting the Board's Field Representative that the documents are ready for his review; and,
- (e) maintain records detailing and documenting his compliance with the provisions of this probation order which records shall be available for inspection at any time during normal business hours upon request of the staff of the Board; and

VIOLATION(S):

- 1.On July 20, 2018, Respondent Timothy Kinney became the qualifier for Total Solar Solutions and the firm was issued an unlimited electrical license with license number U 27029.
- 2.On January 11, 2021, Respondent's license was revoked Pursuant to an Order of the Board that was issued on December 10, 2020.
- 3.The December 10, 2020 Order of the Board found that Respondents violated the terms and conditions of a previously agreed upon November 19, 2019 Notice of Violation that was approved by the Board as a Final Decision of the Board on February 27, 2020. That agreed upon November 19, 2019 Notice of Violation put in place several terms and conditions of probation.
- 4. The November 19, 2019, Notice of Violation was issued as against Respondents arising from, inter alia, concerns about: failing to provide invoice and payroll documentation in a timely manner; engaging in business as an electrical contractor in a name other than how the license was listed,

using non bona fide employees, and failing to timely correct deficiencies for a project at 146 Red Tip Lane, Mooresville, NC.

- 5. The November 19, 2019 Notice of Violation reprimanded Respondents, assessed a \$500 .00 civil penalty against Respondents, and placed Respondents on probation with certain conditions for a period of 1 year.
- 6. Among the conditions of the probation were that Respondents were to:
- a. Obtain and maintain written contracts or proposals for all projects having a project value in excess of \$100.00 signed by the licensee and the customer for all work for which an electrical license is required;
- b. Obtain permits prior to commencing work for all work for which an electrical license is required;
- c. Obtain inspections within 10 days of substantial completion of the work for all work for which an electrical license is required;
- d. Engage in business only in the name in which their electrical license is listed for all work for which an electrical license is required; maintain and make available to Board staff upon request records detailing and documenting compliance with the terms of probation; and commit no further violations of Article 4 of the General Statutes of North Carolina or the Administrative Rules of the Board.
- 7. Another of the conditions of the probation was that Respondents were to complete a Laws and Rules Class by April 30, 2020 and a separate Disciplinary Business Class by April 30, 2020.
- 8. The November 19, 2019 Notice of Violation stated that a failure to comply with the terms of the agreed to probation set forth in that Notice would result in a 12 month suspension of the Respondents' license and the right of the individual Respondent to serve as a qualified individual for any firm for a 12- month period. The November 19, 2019 Notice of Violation also stated that additional sanctions were possible for new violations of the Board's Laws and Rules.
- 9. Thereafter, Respondents failed to comply with the terms of probation in that: Respondents failed to:
- a. obtain and maintain written contracts or proposals for all projects having a project value in excess of \$100.00 signed by the licensee and the customer for all work for which an electrical license is required;
- b. obtain permits prior to commencing work for all work for which an electrical license is required;
- c. obtain inspections within 10 days of substantial completion of the work for all work for which an electrical license is required;
- d. engage in business only in the name in which their electrical license is listed for all work for which an electrical license is required;
- e. maintain and make available to Board staff upon request records detailing and documenting compliance with the terms of probation;
- f. commit no further violations of Article 4 of the General Statutes of North Carolina or the Administrative Rules of the Board;
- g. complete the Laws and Rules class by April 30, 2020; and
- h. complete the Disciplinary Business Class by April 30, 2020 . 10.Respondents submitted that the failure to take the class on time was the result in part of the pandemic and a misunderstanding that there were 2 separate classes.
- 11. The individual Respondent did complete the Laws and Rules class on January 23, 2020 but did not complete the Disciplinary Business Class.
- 12. Respondents were further found to have committed new violations while on probation in that they failed to properly supervise their employees as evidenced by the failure to obtain proper permits, timely inspections and the failure to correct deficiencies on multiple projects.
- 13. The December 10, 2020 Order of the Board noted there was an open question as to whether the Respondent firm was supporting its qualifier's efforts to comply with the terms of probation and his obligations under the Laws and Rules of the Board.
- 14. The December 10, 2020 Order of the Board found there was an unnecessary delay by Respondents in failing to comply with the terms of the probation.
- 15. The December 10, 2020 Order of the Board revoked the license of Respondents but allowed for reinstatement following a personal appearance by both the Qualified ndividual and the Chief Executive Officer of the firm before the Disciplinary Committee of the Board.
- 16. Thereafter, Respondents requested an appearance before the Disciplinary Committee to request reinstatement.
- 17. On April 16, 2020, a Notice was issued by the Board for the purposes of scheduling a hearing before the Disciplinary Committee of the Board as to Respondents' request for reinstatement of their license.
- 18. During their appearance, Respondents appeared and indicated there was a new management team in place and a desire to a) focus on customer service over sales and b) improve communication and responsiveness to all concerns of local code enforcement authorities, customers and the Board's staff.

Respondents also presented updated operating procedures for consideration . Respondents indicated a willingness to restrict the number of ongoing projects during any period of probation following reinstatement.

19. The Panel of the Disciplinary Committee finds Respondents have demonstrated good cause to allow for a reinstatement of the license of the Respondent firm and the right of Respondent Kinney to serve as a listed qualified individual for any firm, subject to the terms of a 5-year probation.

- 1. That the Board impose a civil penalty of \$500.00 upon the licensee. 2 . That the license of Respondent firm and the status of Respondent
- 2. Timothy Curtis Kinney as a qualifying individual be reinstated subject to the terms of probation set forth below and upon the approval of this Recommended Order as a final Order of the Board.
- 3. . Upon reinstatement, the Respondent firm's license to engage in business as an electrical contractor and the individual Respondent's qualification shall be placed on probation for a period of five (5) years, effective upon final action by the Board.
- 4. During the period of probation, Respondents shall comply with the following conditions of probation:
- a. obtain and maintain written contracts or proposals for all projects having a project value in excess of \$100.00 signed by the licensee and the customer for all work for which an electrical license is required that must be signed after the reinstatement of license;

- b. obtain permits prior to commencing work for all work for which an electrical license is required;
- c. obtain inspections within 10 days of substantial completion of the work for all work for which an electrical license is required;
- d. engage in business only in the name in which their electrical license is listed for all work for which an electrical license is required;
- e. maintain and make available to Board staff upon request records detailing and documenting compliance with the terms of probatio11;
- f. commit no further violations of Article 4 of the General Statutes of North Carolina or the Administrative Rules of the Board; and
- g. shall not perform more than three (3) jobs a week in North Carolina for the first six (6) months of probation.

- 3. The June 8, 2019 Notice of Violation reprimanded Respondents, assessed a
- \$500.00 civil penalty against Respondents and placed Respondents on probation with certain conditions for a period of 1 year.
- 4. Among the conditions of the probations were that Respondents were to do the following:
- a. Complete the Laws and Rules class by November 30, 2019; and
- b. Obtain a final inspection on the 14 projects more specifically identified in the June 8, 2019 Notice of Violation.
- 5. The June 8, 2019 Notice of Violation stated that a failure to comply with the terms of the agreed to probation set forth in that Notice would result in a 12 month suspension of the Respondents' license and the right of the individual Respondent to serve as a qualified individual for any firm for a 12 month period.
- 6. On June 24, 2019 Respondents agreed to the terms and conditions set forth in the June 8, 2019 Notice of Violation.
- 7. The June 8, 2019 Notice of Violation was approved by the Board as a Final Decision on September 12, 2019.

- 1. This Board was created Pursuant to the provisions of Article 4, Chapter 87, of the General Statutes of North Carolina and has the authority to discipline conduct and sanction licensees Pursuant to N.C.G.S. §87-47.
- 2. N.C.G.S. §87-47 provides that the Board may revoke or suspend the qualification of a qualified individual or refuse to issue a license, for, inter alia, misconduct or misrepresentation in the practice of or in carrying on the business of electrical contracting.
- 3. N.C.G.S. §87-47 (al) prohibits the following:
- (1) Offering to engage or engaging in electrical contracting without being licensed.
- (2) Selling, transferring, or assigning a license, regardless of whether for a fee.
- (3) Aiding or abetting an unlicensed person, partnership, firm, or corporation to offer to engage or to engage in electrical contracting.
- (4) Being convicted of a crime involving fraud or moral turpitude.
- (5) Engaging in fraud or misrepresentation to obtain a certification, obtain or renew a license, or practice electrical contracting.
- (6) Engaging in false or misleading advertising.
- (7) Engaging in malpractice, unethical conduct, fraud, deceit, gross negligence, gross incompetence, or gross misconduct in the practice of electrical contracting.
- 4. Respondents' actions violated N.C.G.S. § 87-47, as well as the provisions of the June 8, 2019 Notice of Violation.
- Based upon the foregoing Findings of Fact and Conclusions of Law, it is the recommendation of the Committee that the Board enter the following order as to the licensee and the firm:
- 1. Respondents' license be SUSPENDED for a period of 12 months beginning on August 1, 2020 unless Respondents, prior to August 1, 2020, produce sufficient documentation to staff that Respondents have obtained fina I inspection and approval on the 14 projects identified in paragraph 3 on pages 1 and 2 of the June 8, 2019 Notice of Violation or in the alternative Respondents produce sufficient documentation of a sincere effort to obtain passing final inspections by a combination
- of sworn statements from homeowners and local inspectors or certified letters to homeowners and local inspectors that demonstrate a sincere effort to obtain passing final inspections on each of the 14 projects.

- 2. Following any reinstatement of license, Respondents shall be placed on probation for a period of 12 months.
- 3. In the event Respondents' license is not suspended, due to their successful efforts to produce the documentation set forth in paragraph 1above, then Respondents' probation of 12 months shall commence on August 1, 2020.
- 4. During any period of probation, the Respondents shall:
- a) Commit no violations of Article 4, Chapter 87 of the North Carolina General Statutes or the Rules of the Board with regard to any qualification administered by the Board;
- d) Implement procedures and supervision adequate to assure that jobs typically pass both rough-in and final inspection without re inspection;
- e) implement procedures within his business adequate to assure that final inspection is requested within five (5) days of substantial completion of each installation, and that the results of the inspection request are known and of record in the business within a like period of time;

- g) obtain no permits except for work for which Respondent or the firm in which his license is listed receives all contractual payments, for which Respondent or his firm have the contract with the property owner or general contractor, and for which all work is carried out by Respondent or his employees;
- h) Obtain permits as required prior to beginning work on any installation;
- i) Have written contracts signed by the licensee and customer for each installation for which licensee is responsible;
- j) Maintain job files or other written records of contracts made and installations performed; and
- k) Maintain the foregoing records, receipts and contracts for immediate review by the staff of the employees; Board upon request. his
- h) Obtain permits as required prior to beginning work on any installation;
- i) Have written contracts signed by the licensee and customer for each installation for which licensee is responsible;
- j) Maintain job files or other written records of contracts made and installations performed; and
- k) Maintain the foregoing records, receipts and contracts for immediate review by the staff of the Board upon request.

There was no objection from Art Burton Johnson the Recommended Order was approved by the Board as a Final Decision June 18, 2021.

- 1. The Petitioner, Josh Squillacioti, has been the holder of a Special Restricted Electric Sign Classification License with the number SP.ES.28497.
- 2. The license of Petitioner was issued on September 25, 2009 and allowed to expire on September 22, 2017.
- 3. On March 15, 201 8, Petitioner was convicted of 6 counts of Sexual Exploitation of a Minor in the Second Degree.
- 4. The aforementioned crimes occurred in the context of viewing pornographic images online. Petitioner maintains he was not aware the images were of individuals under the age of 18. Petitioner completed all court mandated punishment and rehabilitation.
- 5. Petitioner did not attempt to renew his license after his arrest for the above crimes.
- 6. On March 27, 2020, Petitioner submitted a Request for Reinstatement.
- 7. The Board considered the age of Petitioner at the time of the crime and now, his efforts to rehabilitate himself, the amount of time that has passed since the crimes, the reference letters submitted on his behalf, the connection between the crime in question and a license that will be used to install exterior signs and the Petitioner's business plans.
- 8. In the interim, Petitioner engaged in electrical contracting and did so without being properly licensed to do so.
- 9. Petitioner engaged in unethical conduct and misconduct in violation of N.C.G.S. §87-47 by engaging in business as electrical contractor with an expired license.

- 1. This Board was created Pursuant to the provisions of Article 4, Chapter 87, of the General Statutes of North Carolina and has the authority to discipline conduct and sanction licensees Pursuant to N.C.G.S. §87-47. N.C.G.S. §87-47 provides that the Board may revoke or suspend the qualification of a qualified individual or refuse to issue a license, for, inter alia, misconduct or misrepresentation in the practice of or in carrying on the business of electrical contracting. N.C.G.S. §87-47 (a1) prohibits the following:
- (1) Offering to engage or engaging in electrical contracting without being licensed.
- (2) Selling, transferring, or assigning a license, regardless of whether for a fee.
- (3) Aiding or abetting an unlicensed person, partnership, firm, or corporation to offer to engage or to engage in electrical contracting.
- (4) Being convicted of a crime involving fraud or moral turpitude.
- (5) Engaging in fraud or misrepresentation to obtain a certification, obtain or renew a license, or practice electrical contracting.
- (6) Engaging in false or misleading advertising.
- (7) Engaging i n malpractice, unethical conduct, fraud, deceit, gross negligence, gross incompetence, or gross misconduct in the practice of

electrical contracting.

- 2. Petitioners actions in contracting with an expired license violated N .C.G.S. § 87-47 and are grounds for discipline including probation.
- 3. Reinstatement is in the discretion of the Board, and the burden is upon Petitioner to establish adequate cause to do so.
- 4. The foregoing Findings of Fact establish change in the Petitioner or action by Petitioner adequate to satisfy the Board that the interest of the public would be well-served by granting the request of the Petitioner.

Based upon the foregoing Findings of Fact and Conclusions of Law, it is the recommendation of the Committee that the Board enter the following order as to the licensee and the firm:

- 1. Petitioner's license be reinstated.
- 2. Upon reinstatement of Petitioner's license, his license will be placed on probation for 12 months;
- 3. During any period of probation, the Petitioner shall:
- a) Commit no violations of Article 4, Chapter 87 of the North Carolina General Statutes or the Rules of the Board with regard to any qualification administered by the Board;
- d) Implement procedures and supervision adequate to assure that jobs typically pass both rough-in and final inspection without reinspection;
- e) implement procedures within his business adequate to assure that final inspection is requested within five (5) days of substantial completion of each installation, and that the results of the inspection request are known and off record in the business within a like period of time:
- t) Implement procedures to call for reinspection, if necessary, within ten (10) days after the request for final inspection;
- g) obtain no permits except for work for which Petitioner or the firm in which his license is listed receives all contractual payments, for which Petitioner or his firm have the contract with the property owner or general contractor, and for which all work is carried out by Petitioner or his employees;

- 6. On June 26, 2019, Respondents agreed to the terms and conditions set forth in the May 15, 2019, Notice of Violation
- 7. The May 15, 2019, Notice of Violation was approved by the Board as a Final Decision on September 12, 2019.
- 8. Thereafter Respondents failed to comply with the terms of probation in that: Respondents failed to complete the Contractor Business Disciplinary Course by September 30, 2019.
- 9. Respondents demonstrated that the Course was later completed and maintain the delay was the result of an oversight and not intentional.
- 10. There was an unnecessary delay by Respondents in failing to comply with the terms of the probation.
- 11. Respondents engaged in misconduct in violation of N.C.G.S. §87-47.

BOARD ACTION:

1. This Board was created Pursuant to the provisions of Article 4, Chapter 87, of the General Statutes of North Carolina and has the authority to discipline conduct and sanction licensees Pursuant to N.C.G.S. §87-47. N.C.G.S. §87-47 provides that the Board may revoke or

suspend the qualification of a qualified individual or refuse to issue a license, for misconduct or misrepresentation in the practice of or in carrying on the business of electrical contracting. N.C.G.S. §87-47 (al) prohibits the following:


- (1) Offering to engage or engaging in electrical contracting without being licensed.
- (2) Selling, transferring, or assigning a license, regardless of whether for a fee.
- (3) Aiding or abetting an unlicensed person, partnership, firm, or corporation to offer to engage or to engage in electrical contracting.
- (4) Being convicted of a crime involving fraud or moral turpitude.
- (5) Engaging in fraud or misrepresentation to obtain a certification, obtain or renew a license, or practice electrical contracting.
- (6) Engaging in false or misleading advertising.
- (7) Engaging in malpractice, unethical conduct, fraud, deceit, gross negligence, gross incompetence, or gross misconduct in the practice of electrical contracting.
- 2. Respondents' actions violated N.C.G.S. § 87-47, as well as the terms of the probation as set forth in the May 15, 2019 Notice of Violation.


Based upon the foregoing Findings of Fact and Conclusions of Law, it is the recommendation of the Committee that the Board enter the following order as to the licensee and the firm.

- 1. Respondents existing probation be extended for a period of 24 months.
- 2. During any period of probation, the Respondents shall:
- a) Commit no violations of Article 4, Chapter 87 of the North Carolina General Statutes or the Rules of the Board with regard to any qualification administered by the Board;
- d) Implement procedures and supervision adequate to assure that jobs typically pass both rough-in and final inspection without reinspection;
- e) implement procedures within his business adequate to assure that final inspection is requested within five (5) days of substantial completion of each installation, and that the results of the inspection request are known and of record in the business within a like period of time;
- f) Implement procedures to call for reinspection, if necessary, within ten (10) days after the request for final inspection;
- g) obtain no permits except for work for which Respondent or the firm in which his license is listed receives all contractual payments, for which Respondent or his firm have the contract with the property owner or general contractor, and for which all work is carried out by Respondent or his employees;
- h) Obtain permits as required prior to beginning work on any installation;
- i) Have written contracts signed by the licensee and customer for each installation for which licensee is responsible;
- j) Maintain job files or other written records of contracts made and installations performed; and
- k) Maintain the foregoing records, receipts and contracts for immediate review by the staff of the Board upon request.

There was no objection from Saladeen Kwablah Dalton. The Recommended Order was approved by the Board as a Final Decision June 18, 2020.
