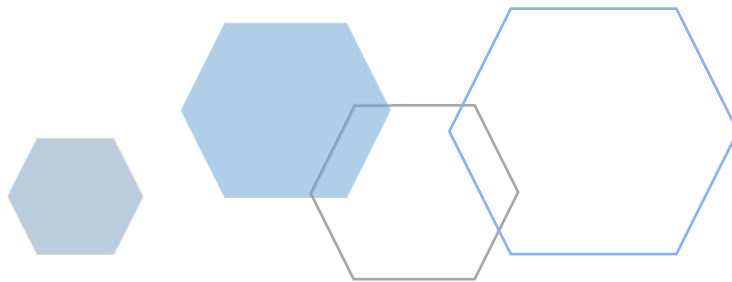
NEW BOARD MEMBER

SYNCHRONOUS VIRTUAL LEARNING COURSE UPDATE

NEW GUIDELINES FOR “SYNCHRONOUS VIRTUAL LEARNING” ONLINE CONTINUING EDUCATION COURSES

A special virtual style of CE course was introduced by the Board in 2020 as an alternative to in-person classroom courses during the COVID pandemic. When taking a Synchronous Virtual Learning CE class, instead of reporting in-person to the class, the individual completes the class online through a live video meeting platform with the instructor and other class participants. Essentially, these live online classes were approved by the Board so that licensees could gain their in-person classroom continuing education credit hours without having to leave their homes during the pandemic.

Recently, the Board revisited the topic and Synchronous Virtual Learning was approved on February 24, 2022 as “classroom continuing education” indefinitely. This means that the Synchronous Virtual Learning courses will continue to be offered as an approved CE option and attendees will continue to gain in-person, classroom, credit hours for attending these virtual courses.

CE Providers who wish to provide synchronous virtual learning must obtain approval by the Board’s staff. Providers must apply before the Governor rescinds his Executive Covid Virus Order. The requirements for providers and instructors are as follows:

- Synchronous virtual learning classes shall not exceed 25 attendees. Classes with 13 – 25 attendees will require an additional proctor to observe the attendees.
- The provider must supply the Board’s Staff the log in information when requested by Board’s staff.
- Provider shall verify identity of attendees before the class by a photo ID.
- Participation requirements are to remain the same as classroom requirements in that instruction shall be for at least 50 minutes per hour.
- Instructors shall engage the attendees and encourage interaction, questions, and discussion.
- Attendees must have capability to hear, see and the ability to ask and answer questions.
- At the end of each class, attendees must complete an evaluation provided by the Board to receive credit. The provider is responsible for keeping the cumulative evaluation information to provide to the Board upon Board’s staff request.

LICENSEE PERMIT WARNINGS

PERMIT WARNING AFFIDAVITS ISSUED TO AND CONSENTED TO BY FIRST OFFENSE LICENSE HOLDERS

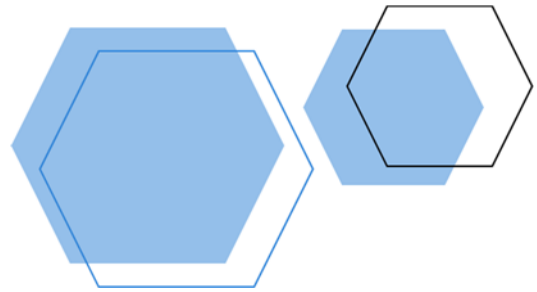
Staff obtains, by consent, a permit warning affidavit in connection with first offense permit and inspection problems under the purview of the Board.

The North Carolina Electrical Contracting Licensing Laws and Rules of the Board have been explained to each licensee representative and/or listed qualified individual listed. Staff obtained by consent a permit warning affidavit signed by the licensee representative and/ or listed qualified individual and assurance from the licensee representative and/or listed qualified individual stating that they understand the requirements and will be in full compliance with the laws and rules applicable to electrical contracting.

The Licensee representative and/or listed qualified individual also acknowledges that further violations of this nature, if supported by evidence, could lead to formal proceedings against the licensee and listed qualified individual by the Board and to more serious sanctions against the license of the firm.

WARNINGS: NON-LICENSEE

WARNINGS AND WARNING AFFIDAVITS ISSUED TO FIRST OFFENSE UNLICENSED INDIVIDUALS

Staff may obtain by consent a warning affidavit in connection with the first offense of unlicensed individuals offering to engage in electrical contracting as defined in Article 4, Chapter 87 of the General Statutes of North Carolina. The Board may apply to the courts to restrain and enjoin such violations as unlicensed individuals engaging in electrical contracting. The North Carolina Electrical Contracting Licensing Laws, specifically General Statutes 87-43, 87-43.1 and 87-48 has been explained to everyone listed below.

Staff obtained by consent a sworn warning affidavit signed by the unlicensed individual and verbal assurance from the unlicensed individual stating that they will refrain from engaging or offering to engage in any electrical contracting in the State of North Carolina until such time they have qualified and obtained an electrical contracting license from the Board.

COURT ACTION: Civil action instituted in Wake County Superior Court resulting in the entry of a Court Order on April 30, 2021 whereby James Born is permanently restrained from engaging in the business of electrical contracting as defined in Article 4, Chapter 87 of the General Statutes of North Carolina, until such time respondent has been issued a license from the Board. The defendant was assessed with the costs of this action.

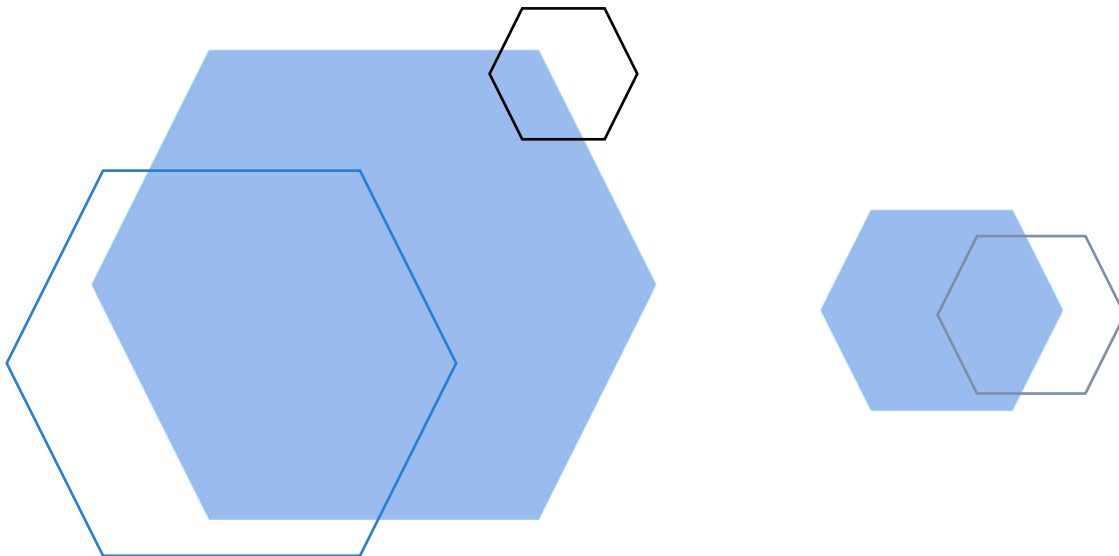

BOARD ORDERS

CASE FILE NUMBER: 2020-291

LICENSEE: Gwyn Electrical Plumbing Heating and Cooling Inc

LISTED QUALIFIED INDIVIDUAL: Jack Preston Wyrick Jr.

VIOLATION(S):

1. February 25, 2021, Respondent issued a Notice of Violation that included a civil penalty and a twelve (12) month probation.
2. The Respondent previously agreed to those terms on October 8, 2020. The February 25, 2021, approved Notice of Violation included as a condition of the probation, that Respondent obtain final inspections on a list of over 50 permits by March 31, 2021. Respondents failed to demonstrate to the Board that those final inspections were obtained on the permits by the deadline, thereby violating the terms of their probation.
3. Pursuant to the terms of the February 25, 2021, Notice of Violation, the license, and qualifications of the Respondent are to be suspended for a period of twelve (12) months for any violation of probation.
4. Respondents has since documented efforts to obtain final inspections on many of the above addresses and stated the delay in compliance was partly due to confusion on the Respondents part as to how he should document compliance.
5. The Board panel found good cause to deviate from the sanction set forth in the February 25, 2021 Notice of Violation.

BOARD ACTION:

1. License of Respondent firm and the status of Respondent Jack Preston Wyrick, Jr. as a qualifying individual be placed on an extended period of probation for a period of twelve (12) months.
2. Probation entails various conditions with which Respondent shall comply.
3. In the event of violation of terms of the probation, Respondents' license and qualifications will be suspended for 12-months and the Board may impose additional sanctions as indicated by any new violations of G.S. 87-47.

CASE FILE NUMBER: 2021-066

LICENSEE: Titan Solar Power NC, Mesa, AZ

LISTED QUALIFIED INDIVIDUAL: Thomas Lynn Porter

VIOLATION(S):

1. On February 14, 2020, Respondent was issued an unlimited license with the number U 33714 with Mr. Porter as the qualifier. Since the current issues here, Respondent has added a new qualified individual, Brad Lookadoo, who was not responsible for any of the issues set forth below.
2. Respondents failed to timely complete a project on Waitsfield Ct., Greensboro, NC as well as other projects in North Carolina.

3. Respondents allowed electrical installations to be installed under their license without proper supervision that resulted in violations of the State Electrical Code and failed inspections for various installations in North Carolina.
4. Respondents maintained a branch office without a qualified individual in Charlotte, NC.
5. Respondents continued to operate their business in names other than how the license was listed with the Board.
6. Respondents failed to cooperate with Board staff during the investigation of these matters.
7. Respondents failed to meet with local electrical inspectors on multiple projects despite the inspectors' requests to do so.
8. Respondents deny any intentional wrongdoing or violation of the Board's Laws and Rules but agree that sufficient facts exist to support the entry of a Board Order and consent.
9. Respondents engaged in misconduct in violation of N.C.G.S. §87-47, committed malpractice as defined by Rules 21 NCAC 18B.0908 and 21 NCAC 18B.0909 and failed to provide the required supervision as defined by Rule 21 NCAC 18.0907.

Due to the corrective action plan of Titan Solar Power and based on the agreement of all parties, the discipline here is directed towards the individual Respondent, Mr. Porter, only.

BOARD ACTION:

1. Respondent Porter's qualification and license is suspended for a period of 6-months.
2. Following the reinstatement of the license, Respondent Porter shall be placed on probation for a period of 24-months.
3. During probation, the Respondent shall comply with various conditions.
4. This Order does not limit or discipline the qualifications issued to Brad Lookadoo and does not prevent TITAN SOLAR POWER NC, INC. from maintaining an active license under a qualified individual other than Respondent Porter during the period of suspension and probation.
5. In the event Respondents fail to comply with the terms of probation, then Respondents will be subject to additional discipline, which may include revocation.

LISTED QUALIFIED INDIVIDUAL: Joseph David Buckner

VIOLATION(S):

1. Respondents failed to obtain the required electrical permit for an electrical installation on Hills Rd., Belmont, NC.
2. Respondents failed to correct deficiencies in a timely manner at the above address.
3. Respondents failed to supervise an electrical project located at the above address by not providing the attendance, participation and oversight sufficient to ensure that the project was carried out in an appropriate manner, and as further evidenced by the fact that the installation was not made properly, safely and in accordance with applicable codes and rules.
4. Respondents failed to complete or abandoned the project located at the above address . Respondents maintain they left the above project over a financial dispute.
5. Respondents aided and abetted unlicensed activity by using non bona fide employees to assist in performing electrical wiring.
6. Respondents failed to cooperate and contact board staff in a timely manner.
7. Respondents made misrepresentations on their annual renewal forms by re-submitting signatures from license renewal forms from previous years.
8. Respondents engaged in malpractice and unethical conduct in the use of their license.

BOARD ACTION:

Respondents' license and qualifications be placed on probation for a period of 12-months.

During the period of probation, the Respondents shall comply with various conditions of the probation.

CASE FILE NUMBER: 2021-0104

LICENSEE: Eugene Levell Wigley, Clayton, NC

LISTED QUALIFIED INDIVIDUAL: Eugene Levell Wigley

VIOLATION(S):

1. Respondent, Eugene Levell Wigley, holds an electrical license with the number U.11452 and at the relevant time was the qualifier for W3 Electric Inc.
2. Respondent Wigley failed to be regularly on full-time active duty at the time in question.
3. Respondent Wigley was partially retired and only on duty at W3 Electric for approximately 20-hours a week at the relevant time though the business was open full-time .
4. Respondents failed to supervise an electrical project located on Page Square Drive, Cary, by not providing attendance, participation and oversight sufficient to ensure that the project is carried out in an appropriate manner, and that the installation was made properly, safely and in accordance with applicable codes and rules.

5. Respondents engaged in gross negligence within the meaning of G.S. 87-47 in that they energized the electrical system at Page Square Drive, Cary, and left that system energized without a final inspection approval, creating a clear and present danger of personal injury or death.
6. Respondents engaged in malpractice in the use of an electrical license.
7. Respondent firm presently has another qualifier listed - Filip Zanat.

BOARD ACTION:

1. Respondent Wigley 's qualifications shall be suspended for a period of 6-months.
2. Respondent Wigley may obtain reinstatement of his qualifications after the passage of 6-months contingent upon various conditions being met.
3. Following any reinstatement of his qualifications, Respondent Wigley shall be placed on probation for a period of two (2) years.
4. The license of Respondent firm, W3 Electric, shall not be suspended but shall be placed on probation for a period of two (2) years if it maintains a qualifier other than Respondent Wigley during that time-period.
5. During the period of probation, the Respondents shall comply with the various conditions set forth by the Board.

EFFECTIVE: 1/09/2022

CASE FILE NUMBER: 2021-202

INDIVIDUAL: Abraham Richard Beardsley, Charlotte, NC

VIOLATION(S):

1. On May 7, 2021 Applicant submitted an application to take the examination to qualify for issuance of an Unlimited Electrical license.
2. Applicant was referred to the Disciplinary Committee for consideration of his character by a referral letter issued on October 8, 2021 for questions as to the documentation of sufficient experience.
3. Applicant appeared on October 28, 2021, confirmed his desire for a license, and answered questions regarding his experience.
4. A significant portion of the hours submitted by Applicant occurred at a time his employer was operating an improperly licensed office in Charlotte raising questions as to supervision.
5. Applicant is believed to have the ability to better document his experience if allowed to supplement his application. Applicant has indicated he would like to supplement his application and that he would accept qualifications and a license conditioned on the satisfaction of probationary terms.
6. The Committee considered the Applicant's work history, his future business plans, and efforts towards rehabilitation and licensure. The Committee finds a need for satisfaction of conditions prior to the issuance of a probationary license and finds that the Applicant does not appear to be a present risk to others and can satisfy the character and experience requirements subject to the terms and conditions of this Recommended Order.

BOARD ACTION:

1. Applicant will be allowed to sit for the examination for an unlimited license only after Applicant submits an amended application with supplemental materials to satisfy staff as the existence of a sufficient number of hours of experience.
2. If successful on the examination for an unlimited license, then Applicant must attend and pass the free Laws and Rules Class offered by Board staff, prior to the issuance of any electrical license.
3. Upon issuance of a license, Respondents' license shall be placed on unsupervised probation for a period of 12-months.
4. During the 12-month period of probation, the Respondents shall comply with the various conditions of probation as set forth by the Board.

CASE FILE NUMBER: 2021-201

INDIVIDUAL: Christopher Lowe Verner, Fort Mill, SC

VIOLATION(S):

1. On June 28, 2021 Applicant submitted an application to take the examination to qualify for issuance of an Unlimited Electrical license.
2. Applicant was referred to the Disciplinary Committee for consideration of his character by a referral letter issued on October 8, 2021 for issues as to character and also questions as to the documentation of sufficient experience.
3. Applicant appeared on October 28, 2021, via a virtual appearance, confirmed his desire for a license, and answered questions regarding his character and experience.
4. Applicant's application, inter alia, disclosed a felony conviction with an offense date of 1/28/16. Additional documentation regarding that matter was requested by staff in advance of the hearing.
5. Applicant provided sufficient background information and evidence of his rehabilitation as that criminal history.
6. A significant portion of the hours submitted by Applicant occurred at a time his employer was operating an improperly licensed office in Charlotte raising questions as to supervision.
7. Applicant was believed to have the ability to better document his experience if allowed to supplement his application. Applicant has indicated he would like to supplement his application and that he would accept qualifications and a license upon the satisfaction of probationary terms.

8. The Committee considered the Applicant's work history, his future business plans and efforts towards rehabilitation and licensure. The Committee finds there to be a need for satisfaction of conditions prior to the issuance of a probationary license and finds that the Applicant does not appear to be a present risk to others and can satisfy the character and experience requirements subject to the terms and conditions of this Recommended Order.

BOARD ACTION:

1. Applicant will be allowed to sit for the examination for an unlimited license only after Applicant submits an amended application with supplemental materials to satisfy staff as the existence of a sufficient number of hours of experience .
2. If successful on the examination for an unlimited license, then Applicant must attend and pass the free Laws and Rules Class offered by Board staff, prior to the issuance of any electrical license.
3. Upon issuance of a license, Respondents' license shall be placed on unsupervised probation for a period of 12-months.
4. During the 12-month period of probation, the Respondents shall comply with various terms of probation.

5. Respondent Bonds maintains that difficulties in his personal life impacted him and were a partial cause of any problems. The panel found no good cause to deviate from the probation sanctions but finds cause to add conditions prior to any reinstatement of license and qualifications and to place Respondents on probation after any reinstatement.
6. Respondents exceeded the scope of their Limited license by bidding and performing an electrical project for a Carlie' C's Operation Center in Dunn, NC, which was beyond the scope of their Limited license.

BOARD ACTION:

1. License of Respondent firm Bonds Electric, LLL and the status of Donald Clark Bonds, Jr. as a qualifying individual be suspended for a period of twelve (12) months.
2. During the period of suspension and prior to any reinstatement of qualification and license, the Respondents must comply with the various conditions set forth in the Order.
3. Following any reinstatement, the license of Respondent firm and the status of Respondent Bonds as a qualifying individual be placed on an extended period of probation for a period of twenty-four (24) months.
4. During the period of probation, Respondents shall comply with the various conditions of probation.
5. In the event of violation of terms of the probation, the license will be revoked and the Board may impose such additional sanctions as indicated by any new violations of G.S. 87-47.

9. Respondent Stoner presented insufficient evidence of rehabilitation and has not completed his criminal sentence. Respondent Stoner has additional pending criminal charges.
10. Respondent Stoner was convicted of a crime involving moral turpitude. The panel considered Respondent's age at the time of the crime and at present and his rehabilitation efforts.
11. The Panel is of the opinion that Respondent has not yet demonstrated the public will be protected if his license and qualification are reinstated, however the Panel believes that Respondent may be able to demonstrate the public will be protected if certain restrictions are placed on the license after successful completion of his probation if there are not additional criminal convictions.
12. If the applicant makes a personal appearance before the Committee after successful completion of his probation and after meeting various other conditions and requirements, then the Panel is inclined to allow the reinstatement of Respondent's license and qualifications, subject to the standard terms of probation for a 12-month period.

BOARD ACTION:

The license of Respondent firm and the status of Respondent Christopher Dale Stoner as a qualifying individual will NOT be reinstated at this time.
